**REGULATOR APPROVED CHANGE IN TARIFF PER UNIT OF ELECTRICITY. THIS ORDER OF THE REGULATOR REVOKES ORDER NO 2021/E78.**

The following tariff charges shall become effective commencing **01 September 2021**


